Reporting directly to the VP, Global Compliance, this position will be responsible for developing strategic direction, compliance guidance, training, as well as implementing and maintaining all aspects of compliance in Europe. This position will serve as a critical and valued member of the Compliance and Legal team and will partner with other key stakeholders in the business by providing business-oriented and pragmatic guidance that enables the company to achieve its compliance obligations, purpose, and goals within Europe.

Responsibilities include but are not limited to:

- Provide strategic direction and compliance leadership to the region
- Actively participate and serve on regional leadership teams, providing compliance guidance consistent with the Company's culture and values to promote ethical behavior, and enhance the Novavax global compliance program
- Develop compliance policies and procedures that integrate appropriate healthcare, corporate, privacy and other compliance controls to guide the company's operations
- Directs the execution of a training program through a matrix organizational structure across multiple departments for new and existing employees to ensure a thorough understanding and appreciation of the laws that impact the company's operations and how to conduct business practices appropriately
- Provide timely guidance and compliance oversight on company initiatives, such as training initiatives on applicable
 laws, regulations and NVX policies/procedures, FMV assessments, HCP consulting agreements, advisory boards,
 speaker programs, sponsorships, grants, and other initiatives involving interactions with healthcare professionals,
 healthcare organizations and patients/advocacy groups
- Identifies emerging industry and company trends to mitigate compliance risks through preparation and preemptive education
- Identify opportunities for growth and enhancement of the Novavax global compliance program
- Conduct periodic internal reviews, including risk assessment, monitoring, and auditing to support the annual Compliance Risk Assessment, create and implement a compliance action plan and annual monitoring program to ensure adherence to regulatory requirements and internal policies to mitigate risks where necessary
- Partner with internal (e.g., Legal, and Human Resources) and external (e.g., outside counsel or investigators) stakeholders for the conduct and resolution of potential compliance investigations, including the management of any resulting corrective actions plans
- Create and maintain dashboards or other reporting tools to track and assess compliance risks; prepare updates, presentations, and compliance reports for executive management, as necessary.
- May provide support on other policy and procedure implementation governing business operations

Minimum requirements:

- In-depth understanding of the pharmaceutical industry with expertise in the body of laws, regulations, guidance, and codes impacting pharmaceutical companies, including knowledge of compliance issues related to the development and commercialization of branded pharmaceutical products
- Significant experience leading and implementing a global compliance program
- A successful track record building a culture of compliance and ethics in which compliance and business objectives are mutually reinforcing and establishing effective policies, processes, reporting, monitoring, and auditing programs
- Strong problem-solving and decision-making skills with demonstrated ability to think creatively and devise solutions to challenging problems
- Desire and ability to both develop strategy, make decisions and to implement timely, with hands-on creation and delivery of materials and processes
- Must have excellent analytical skills and comfort with multiple data sets, with the ability to draw conclusions and make informed decisions and recommendations
